Re: Letter regarding the suggested Easement as a condition for Pocket Park Sale, 2284 Center Street. Public Comment, Meeting, Thursday October 13, 1 pm on zoom.

## Board Members,

The Cambria Historical Society is writing this letter to clearly re-state our position regarding our consideration to purchase the property at 2284 Center Street aka: the Pocket Park. We are not interested in purchasing the pocket park if it is going to be subject to a newly proposed easement.

I have meet with Kermit Johansson regarding the intentions of the Cambria Historical Society, and our proposed project at the pocket park location. He presented a proposed plan that the Cambria Trail Alliance is working on, including the creation of a bridge over Santa Rosa Creek, giving the public access to a planned trail to tin city. Bridge access shown on the plan presented was the Center Street Pocket Park location.

Mr. Johansson was unfamiliar with the encumbrances on the property and the current conditions under the flood plane designation much less the properties condition before and after the 1969 flood. He had not as of that date, put project questions to SLO County Planning Department, California Fish and Game Agency and others, to clearly see the scope of such a plan.

According to brief conversations, County Planning is understaffed and over loaded and just filing the documents to consider an easement to be placed on any property is years in the completion, and approval of such a plan could be a 10 to 15 year process.

CHS was given information that Kermit Johansson made a motion at the PROS Commission meeting for a recommendation that the Cambria Historical Society would be financially responsible for putting in the Bridge and the paths being considered in the development plan of the Cambria Trail Alliance, to the pocket park property. We were not party to this conversation and are not at all interested.

Our proposed project includes moving the old jail from the Pinedorado grounds to its original historical location, which is the Pocket Park on Center Street. This property is part of the original Historic District plan created by the Pros Commission for Cambria, a project that has been supported and implemented by CHS for years. We will be replacing the fences and adding interpretative materials to the park, telling the history of this section of our community. The seating will remain and serve not only visitors but the merchants and locals we see there daily. We are part of a neighborhood on Center Street with Jim Evans, Forrest Warren, postal workers, A.T.&T. and the main street businesses. We have spent years communicating with the CCSD agency about this project and our intention's for its use. Our contact with Officer Henry and our Sheriffs Department concerning the homeless population and safety for park visitors has been in tact for years as well. Our offer stands as stated. Our best wishes to the Cambria Trail Alliance.
