Thank you for asking for public input on improvements to East Ranch in Cambria.

The increased efforts to ban unleashed dogs in Fiscalini Ranch limits Cambrian's habits of hiking and wandering with their dogs. As a result, the need for dog & people walking areas has increased. We would like to see the current boundaries of the dog park in East Ranch expanded considerably so that dogs and their people could hike around a meadow loop trail. Owners and dogs could continue to use the current dog park as it's configured, but others could wander and sniff along a trail. Our guess is that a meadow trail loop could be designed to be wheelchair/easily accessible. We recognize this would require additional fencing to protect dogs and wildlife and there might be interruption to wildlife corridors. Since dogs are members of so many Cambria families, we hope the compromises needed would be embraced by many.
