MINUTES

1. OPENING

A. CALL TO ORDER

The meeting was called to order by Chair Steve Kniffen.

C. CHAIR REPORT

Steve Kniffen would like permission to have the scarecrow run again on the Ranch. It would take place the second Saturday in October. He would like PROS to be the sponsor. He needs to get permission from Ranch Manager for the run.

2. EX - OFFICIO REPORTS:

JoEllen Butler reported that FFRP is continuing to weed. Monitoring is on going but almost finished and she and Holly Sletteland are meeting with Cal Fire to pursue what needs to be done on the Ranch.

4. GENERAL MANAGER'S REPORT

Jerry Gruber reported on funding of phase one project of the Community park and the remaining money that is required to start the

work. Commissioner Kniffen went to CCSD last board meeting to request additional funding. The funding is in the Budget now for 2017 and 2018, even the dog park fence is included. There will be additional costs with the relocation of the park like chips and furniture. Commissioner Roche said the Membership of the dog park only consists of 15 people down from 60 and we cannot look to them for money especially when they don't want to move in the first place. A long discussion then followed on who could fund the move and the fact that the Community Council had money but wanted big projects and the projects had to be submitted to them in November and then would be funded as a grant in December. It was decided to go with the budget funding for the fence for the dog park. Commissioner Roche was reminded that the dog park is illegal where it is and someday will be forced to move.

5. FACILITIES AND RESOURCES SUPERVISOR

The skate park Ramp is now fixed but the bill for the service is not in yet. They still need two smaller ramps built probably at a cost of \$5,000. Weed abatement has started on the parcels that belong to CCSD. Fire Breaks are getting started on the Ranch. Invasive control of the thistles is high priority. With volunteer help from FFRP it is moving ahead. Erosion control planning is in the works. There is one more issue that has come up and it has to do with the Emergency Road on the East Ranch. Recently it was found that there are two parcels of land that are not owned by CCSD. They are owned by individual owners. This has put a stop to the road and Civil design is pursuing an answer to this problem.

It was purely an informational presentation.
