SUBJECT: 7.C. of May 21, 2020, Agenda: water, SWF, wastewater rate increase

1. I request that you table until July 16, 2020, Item 7.C. on today's Agenda: the resolution to increase water, SWF, and wastewater rates. You have insufficient information about the economic effects of the COVID-19 pandemic on Cambria to make a reasonable, informed decision today about the rate increases. You might have better information in July.

If you approve the rate increase at that meeting, the increase would begin on Sept. 1, 2020, and payment would be due on Nov. 1, 2020.

2. I request that you instruct the General Manager and the Financial Officer to reduce by \$115,000 the expenditures projected for the FY20-21 Budget being prepared. On page 229 of the Agenda today for 7.C., this is the amount posited for delaying the increase for one billing cycle.

The Budget the Board of Directors adopts in June 2020 can be changed as soon as the 2nd quarter of FY 20-21 or later.

3. I request that you consider on your Agenda revisiting your action of May 14, 2020, hiring a consultant to work on the UWMP. Reverse your action and table the hiring. This would free-up \$99,990.

(Minutes of May 14, 2020, meeting are not yet available. Thus I am assuming 6.E., the UWMP proposal was adopted 6.E.)

You could again address hiring the consultant when you have more information about the CDP and the UWMP Guidebook and changes for the UWMP later in the summer of 2020.

4. I request that you table item 7.B. on today's Agenda:

DISCUSSION AND CONSIDERATION TO APPROVE AN AGREEMENT FOR STRATEGIC PLANNING CONSULTING SERVICES WITH SNIDER AND ASSOCIATES.

This would also free up ca. \$4,800 - \$5,500.

This amount is not in the FY19-20 Budget. In the Fiscal Impact discussion of this item 7.B. today, p. 64, it is important to note this statement: "If a budget adjustment is needed, there is a surplus projected for personnel services, of which a portion can be transferred to services and supplies during the 4th quarter budget report."

If such surplus carries over from one FY to the next, this would also set off some of the reduction or postponement of \$115,000 in rate revenue.

As the Covid-19 pandemic is hitting a huge amount of our population, institutions, state agencies, businesses of every kind, are having to make cut-backs to manage their resources in a responsible way--(see links below). I just learned that the Regional Water Quality Control Board, will be furloughing their employees, two days out of every month, as will all state agencies. Morro Bay City Council members are taking a 10% cut in pay--see link below. What is the CCSD doing?

At a time when this pandemic has affected the lives and incomes of millions--37 million have applied for unemployment nationwide, the CCSD has done nothing to reduce costs, but have no problem asking their ratepayers for a significant rate increase. While some folks in Cambria, may be able to absorb more exorbitant costs, others will be struggling. To the Board:

Raising rates at this time, with many people struggling financially ignores the real problems the Covid-19 pandemic has caused.

However, the district is in such deep debt, even this rate increase isn't going to bring in enough money to cover the costs.

The Emergency Water Supply Project has beggared the district. It starts with the annual payments of over \$650,000. That takes a big bite out of district finances right there. But that's never enough. Costs have been running at around a million dollars a year. Currently, the district is also pursuing a \$3.5 million lawsuit against the contractor, which adds to legal expenses. At the last meeting, the board approved another \$100,000 contract related to the plant. Although only about \$25,000 of that is designated for work related to the EWS, the board approved the additional \$75,000, for work on the Urban Water Management Plan, even after the utilities manager told them that he and the district staff could do that work in house.

That's another \$25,000 in the EWS column. The application is not yet complete, six years after the plant was constructed.

So that's the reason the district needs a rate increase. As they have pursued the EWS, they have ignored normal maintenance on water and sewer infrastructure. To address that, they entered into an agreement with PG&E for a Sustainable Solutions Turnkey Program, for an initial payment of about half a million dollars, looking forward to ten million or so more in repairs and upgrades. It's hard to argue against this, either. After years of deferred maintenance, the district's pipes are rusty and its electrical and electronic systems are outdated. Where's that money going to come from?

I feel like a piker for bringing it up, but on today's agenda, the board is considering hiring yet another contractor to come up with a Strategic Plan. I applaud the staff for reducing that to \$4,800 plus travel and expenses. Heck, while they are paying bills in the hundreds of thousands of dollars, what's another five or ten?

So that's why the board is under pressure to raise rates. They need to pay the bills. Cambrians want reliable water and sewer service. They aren't able to stop making those EWS payments and are apparently unwilling to stop hiring contractors to reach for that elusive permit to operate the EWS – despite their own advisor telling them to scale back.

That's where the money's going. The district has continued to spend millions of dollars on the EWS, ignored water and sewer maintenance, and now is in a bind. Now or later, the money can only come from the ratepayers.

Today you are yet again contemplating another rate increase. Like death and taxes over time we can be sure the rates are going to go up.

For quite some time now I have been most disappointed by the expenditures in some areas particularly, the never-ending financial drain presented by the AWTP. This project is slated to receive another 12% of the proposed increase. My question to each of you, is there any amount of money that would be too much to spend on a device that is hundreds of percent over estimates and that your currently suing the manufacturer for non performance? How many hours of staff time and now another 100k of consulting which is really still all about the AWTP CDP, not the water plan?

During the last six years as these CDP machinations have gone on, technology has moved forward in leaps and bounds. Will you be concerned about never ending spending on a machine quickly becoming obsolete? I urge you to please carefully note what I have just written here.

On the other hand I have been urging the district to get our house in order with leak detection and control. I am very pleased to see that process moving well forward. I am all for that and fully accept those additional costs. The available water from a reduction in leak losses of 4 to 5 percent off our average 13% represent a huge change for us!

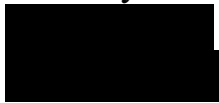
Over the last five years my bill with the same usage has increased almost \$50 a month, \$600 a year. While I might be able to absorb that figure my wife and others delivered food yesterday to many in this town who are struggling to pay their rent and feed their kids much less their utilities.

Many local districts are controlling their costs with reduction measures, adding 100k of yet more consulting is the antithesis of that.

Directors, it is cruel and unusual punishment for those who are struggling financially to implement a rate increase right now. I urge either a no vote or a tabling of this issue until some semblance of stability returns.


