4. General Manager and Facilities and Resources Supervisor Report. Jerry Gruber reported that Phase 1 is in the Budget. Proposition A funds of \$159,296 will be forwarded to the Parks and Recreation Budget to cover phase 1 of the beginning of the development of the East Ranch Community Park.

The next step is to get a Topographic map of the area. It was discussed that Civil Design Studio could do this for us at a cost of \$10,000 (estimate). It would be under the direction of Monty Soto. It will not have to be put out to bid because it is under the amount that demands other bids on projects. We need to reach out to community before we start this project so they are aware of what is happening. Perhaps a press release is in order. Moved and seconded by Commissioner Renshaw and Commissioner Atencio that a special meeting be called next Tuesday and publicized by Kathy Tanner.

Carlos Mendoza reported that the homeless are still a big issue on the Ranch. He had to tear down a house like shelter on the Santa Rosa Trail that was housing three people and a dog. They were local people down on their luck.

Dead trees are a real problem at the moment. In the past six months he has removed 60 dead trees on the Ranch and other District properties. This is almost like a full time job and also an expensive task.

We need to publicize the job it is for the district to take care of the Ranch and the costs involved. Perhaps an article in the Cambrian?

- A. Consideration to approve Minutes of Commissioners meeting January 6, 2015. A motion was made by Commissioner Renshaw and seconded by Commissioner Atencio to approve. It passed.
- B. A discussion followed relating to Dogs off leash on the Fiscalini Ranch Preserve.It seems we cannot ignore the County Ordinance now that we know about it. It was emphasized that there would be no enforcement on CCSD part. The signs that approved of Dogs off leash are down.
