

## **Proposition 4**

Authorizes \$10 billion in Bonds for Safe Drinking Water, Wildfire Prevention, and Protecting Communities and Natural Lands From Climate Risks. Legislative Statute.

How municipalities (including CCSD) can apply for the 2024 California Proposition 4 funds:

- 1. **Application Process**: Municipalities will need to submit detailed proposals outlining their projects and how they align with the goals of Proposition 4. This includes projects related to safe drinking water, wildfire prevention, and protecting natural lands from climate risks.
- 2. **Eligibility Criteria**: Projects must benefit communities with lower incomes or those affected by environmental changes or disasters. There will be specific eligibility criteria that municipalities must meet to qualify for funding.
- 3. **Submission Deadlines**: The exact deadlines for submission will be announced by the Natural Resources Agency in early 2025, but it's advisable to start preparing proposals now to ensure timely submission.
- 4. **Review and Approval**: Submitted proposals will be reviewed by the California State Water Resources Control Board and other relevant agencies. Approved projects will receive funding based on their alignment with Proposition 4's objectives.

How we prepare a strong proposal for the 2024 California Proposition 4 funds:

### 1. Understand the Objectives

**Align with Goals**: Clearly demonstrate how our project supports the objectives of Proposition 4, such as providing safe drinking water, preventing wildfires, and protecting natural lands from climate risks.

### 2. Community Impact

**Highlight Benefits**: Show how our project will positively impact the community, particularly disadvantaged areas or those heavily affected by environmental changes or disasters.

#### 3. Detailed Plan

**Provide Specifics**: Include detailed descriptions of the project scope, timeline, and expected outcomes. Be specific about the tasks, resources needed, and how you plan to achieve our goals.

#### 4. Collaboration

**Partnerships**: Highlight any partnerships or collaborations with other organizations, agencies, or community groups. Collaborative efforts often strengthen a proposal.

### 5. Budget

**Transparent Budgeting**: Present a clear and realistic budget. Breakdown the costs and justify the need for each expense. Transparency in how the funds will be used is crucial.

### 6. Sustainability

**Long-term Vision**: Explain how the project will be sustained over time. This includes maintaining the benefits and ensuring ongoing impact after the initial funding period.

## 7. Compliance

**Meet Requirements**: Ensure our proposal meets all eligibility criteria and complies with the application guidelines provided by the Natural Resources Agency and the California State Water Resources Control Board.

#### 8. Review and Feedback

**Get Input**: Before submission, have our proposal reviewed by colleagues or experts to get feedback and identify any areas for improvement.

Preparing early and meticulously can significantly enhance the chances of our proposal being approved.
