Re: Rotary 'END POLIO NOW' 5k event October 19, 2024

Dear Board members:

Our Rotary Club of Cambria is hosting our second 'END POLIO NOW' 5k event on October 19, 2024 at Shamel Park here in Cambria. Our inaugural event was last year, on October 14, 2023. World Polio Day this year is on Thursday, October 24th. (Please note that when Rotary began this project in the 1985 at the behest of Dr. Albert Sabin, the doctor who created the OPV, Oral Polio Vaccine. IN 1985 there were 350,000+ new cases in the world each year. As of August 29 of this year there have been 33 reported cases in the world. We (WHO and Rotary International) have just received approval from the Israeli and Hamas governments to allow three separate temporary cease fires, 3 days each, to allow for vaccination teams to go into war-torn Gaza to immunize the 650,000 children in that area who would otherwise have no access to routine immunization.)

We began our approval process for this year's event in June of this year, contacting our insurance carrier for the Event COI, the County of San Luis Obispo for all necessary Event and Park approvals, the EMT's and ambulance who will be on site at Shamel Park, and CCSD General Manager Matthew McElhenie and Cambria Fire Chief Michael Burkey, all the same process as we did last year. We replicated last year's process exactly.

We have just been informed that there are additional requirements for this event, these requests from Miriam Torres, CCSD Administrative Technician and Kitty Connolly, Executive Director of the Friends of the Fiscalini Ranch Preserve. Of course our Rotary Club of Cambria is more than willing to cooperate in any way necessary to make this event a success, but we are puzzled by these last minute requests as we started this process in June of this year. To be clear, the event will be held at Shamel Park. The participants start at the Park, traverse the Ranch, and culminate at the Park. All event activities are at the Park. We wanted only to traverse the Ranch, instead of using County streets, to make it safer for our participants. Last year I believe we had only 20 or so participants. We hope for more this year, of course. So far I believe we have 12 participants signed up. Again, we will do whatever is required of us to satisfy any and all governmental and non-governmental agencies. We live here also, this is our town also, and we want to do everything possible to keep our event safe and legal. If there is a concern about groups of people traversing the Ranch, we can time each group and limit each group to less than 25 participants. (We hope to get to 25 participants!) We are just puzzled by these last-minute requests, but again, whatever is required of us please know that we will happily comply.

I will be at the Board meeting today to bring this to the Board's attention in person.

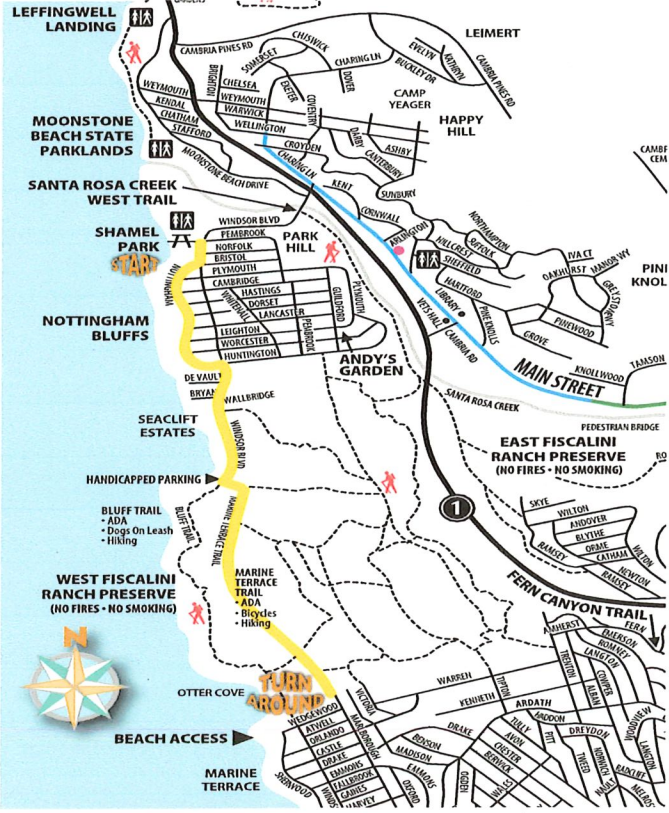

Bullet Points for Rotary International's Polio Eradication Project

- In 1916 there was a polio endemic in New York State.
- Dr. Jonas Salk develops the first vaccine against polio, an injectable inactivated (dead) polio vaccine (IPV) in 1954.
- Dr. Albert Sabin develops the live oral vaccine (OPV) in 1961.
- Rotary's involvement with Polio eradication began in 1979 with a five year commitment to provide and help deliver polio vaccine to six million children in the Philippines. It was the first project of Rotary International's new 3H Grant (Health, Hunger and Humanity Program). It worked! Polio was eradicated from the Philippines.
- Dr. Sabin speaks at the 1980 Rotary International Convention highlighting the 3H Grants success in eradicating polio in the Philippines.
- In the early 1980's Rotary International began planning for the most ambitious program in its history – and arguably in the history of mankind. Carlos Consecro – the Rotary International President from 1984 – 1985 – is considered the father of Rotary's Polio Eradication Project. In 1985, based on its success in the Philippines, Rotary was issued a challenge from Dr. Albert Sabin, the developer of the Oral Polio Vaccine: to eliminate polio from the face of the Earth... and Rotary accepted that challenge. The PolioPlus Program was launched in 1985. Rotary pledged to raise \$120 million to fund the PolioPlus Program. This was announced in October 1985 at the 40th anniversary of the United Nations. Rotary stood alone in the world with PolioPlus.
- Dr. Sabin speaks at the Rotary International Convention in 1985 when the Rotary Polio Plus Program was announced.
- By 1988 Rotary International had raised US\$247 million and the United Nations Children's Fund (UNICEF) joined the Program in that year. The World Health Organization was also approached AFTER that money was raised and they also agreed to join in with Rotary's PolioPlus Program. Also joining up at that time was the United States Centers for Disease Control and Prevention. This partnership (Rotary International, UNICEF, WHO and CDC) formed the basis for the Global Polio Eradication Initiative, created in 1988. Also in 1988 the World Health Assembly passes a resolution to eradicate polio.
- That goal in 1988 became a promise that Rotary gave to the world... to eradicate polio from the Earth. And that promise came with a goal... to complete the task by 2005, the 100th anniversary of Rotary International. We made significant progress, but we did not meet that deadline.
- In 1988 there were 350,000 new cases of polio in the world each year, in 134 countries.
- In 1991 the Western Hemisphere is declared polio-free.
- In 1995 Rotarians immunize 165 million children in a single week in India and China. The Global Polio Initiative partners utilize a new strategy, called National Immunization Days (NIDs), wherein all children in a given country 5 years or under are immunized at the same time
- In 1996 150 countries in the world are polio-free. In that same year Nelson Mandela launches "Kick Polio out of Africa", the eradication project on the continent.
- In 2000 550 million children receive OPV. The Western Pacific Region, Australia to China, is pronounced polio-free.
- In 2003 only 7 countries in the world remain polio endemic (never having interrupted the transmission of the Wild Polio Virus (WPV).
- In 2004 the partners coordinate a synchronized campaign to immunize 80 million children in 23 countries in Africa. Nigeria accounts for 77% of the total new reported cases of WPV in the world, 763 cases.
- In 2024 only 2 polio endemic countries remain in the world – Pakistan and Afghanistan.
- To date (September 12, 2024) there have been 33 cases reported worldwide, including Pakistan and Afghanistan.
- To date Rotary has raised over US\$2 billion!
- 2 billion children have received the OPV vaccine since the start of PolioPlus and will NEVER feel the effects of this dreaded disease!
- We are currently preventing 500,000 new cases a year... ½ million children each and every year who will be able to walk and lead normal lives!
- 20 million children in the world today do not have paralysis because of this PolioPlus project.
- We now have a new OPV (Oral Polio Vaccine) so there will no longer be vaccine derived polio!

PUBLIC COMMENT

At this morning's meeting, the Coastal Commission heard the appeal, entered by two commissioners, of the Brambles permit. The Staff Report was clear in recommending that the Commission deny the permit, due to lack of adequate water.

Applications for new water uses rarely come before the board, although there was some discussion in the past of bringing them to board attention. They are approved by Jim Green and Matt McElhenie. I try to follow them, but missed this one. I'm grateful to the Commissioners who called it out.

The County always approves new construction applications because the CSD sends a staff member to tell the board that the district has determined that it has plenty of water to serve the development. Although the County has an affirmative requirement to determine this independently, they never do, preferring to rely on the CSD's assurance.

The Staff Report calls the district and the county out on their bogus water analysis on pages 2-3 of the Staff Report, which I will attach to my written comments.

And admonishes the county and CSD to stop wasting Commission time and resources on page 3 (emphasis added):

“If the Applicants still want to pursue the project or some variation thereof (e.g., a version that matched existing water usage), then the Applicants are welcome to go back through a County CDP process wherein these issues are appropriately addressed, but it is a not a good use of the Commission staff's scarce resources to attempt to solve such problems through the Commission's CDP process (nor is the Commission required to condition a project to bring it into conformance with the LCP).”

Mr. McElhenie claims the county is responsible for issuing this permit. That's technically true. He's new, so he may not be aware that this evasion of responsibility has been overused by the district and the county. The district claims no responsibility because the county holds Land Use authority. The county claims no responsibility because they rely on the district's assurances of adequate water. Both escape accountability.

Everyone sees what's going on, a bureaucratic shuffle to permit water-using development. Time for the board to be accountable. Apologize to the Coastal Commission for wasting their time. Assure them that you have directed staff to stop approving these permits.

As Dan Carl, Central Coast District Director of the Coastal Commission, wrote in

2022: *“we respectfully request that you not file any more CDP applications for such proposed development unless and until the water supply situation changes in Cambria and there is an adequate/sustainable water supply. To that point we do not believe that a will-serve letter from CCSD as the water purveyor satisfies that requirement, including as the LCP finding that is required on this point is not CCSD’s to make, rather it is the County’s independent responsibility.”*

Please consider the board’s and the staff’s role in these continuing permit denials.

PUBLIC COMMENT

Please explain this item. When will the Regional Water Quality Control Board, Army Corps of Engineers, California Department of Fish & Wildlife (CDFW), the United States Fish & Wildlife Service (USFWS), and National Marine Fisheries Service be consulted for their concurrence, as required? The US Fish and Wildlife Service has designated the creeks as “critical habitat” for multiple federally threatened species, including steelhead. Cindy Cleveland’s March 2022 biological report is inadequate. How can SWCA update the AMP without current data?

If the Project Description as submitted isn’t complete now, what’s missing?

As far as the EWS/SWF/WRF CDP application goes, Coastal Commission staff has no confidence that the project will ever operate, as expressed in the Brambles Staff Report referred to earlier:

There is currently no established timeline for when CCSD might complete its CDP application, when the County might take action on it, and then when potential appeals of a County decision might be made to the Commission. Thus, it is not clear when, or even if, a facility such as is currently proposed may eventually come online, and it is not appropriate to countenance it in relation to whether such water source (if ultimately approved) could provide for new water connections to serve development in an LCP-consistent manner.

What, exactly, can Cambria expect to get for this additional \$36,865? How does it move the EWS/SWF/WRF CDP application any further? Thank you.
