Trip to Washington

In early March, General Manager Rudock visited Washington for our annual trip to Washington to put a local perspective on our request for Federal funding. This year, the Cambria CSD has officially requested \$6,775,000 in funding for the desalination facility. Our request is for the remaining Federal funding currently authorized for the project. It is unlikely that we will be successful in securing that level of funding, but it is paramount that we secure some level of funding as our last appropriation from Congress was in FY 2005.

General Manager Rudock met with the following people during her trip:

I believe the trip was very worthwhile. Even though we officially requested more than \$6 million in funding, we made it clear in each of our meetings that a more realistic funding figure was in the range of \$600,000 to \$900,000. This would keep the project moving forward, particularly in light of the CCSD trying to navigate any future difficulties. Again, our most important goal is simply to receive <u>any</u> Federal funding, regardless of the amount, because of our large delay since the project last secured Congressionally-directed funding. And, while we received no promises of funding, we do have a number of things going for us (we are not a new start, we received ARRA funding, etc) that should help our cause with Congress.

Earmark Issues

You may have heard news items recently discussing earmarks in Washington. On March 10, the House Appropriations Committee announced that they would no longer fund projects for <u>for-</u>

<u>profit</u> entities (think defense contractors). On March 11, the Republican House Caucus attempted to one-up the Democrats by indicating that no House Republicans would seek earmarks in Fiscal Year 2011.

The Senate is not inclined to follow suit and in fact has released a number of statements calling the House moves "quizzical". And, House Democrats do not intend to do anything further than what they've already done with their "earmark reforms" of the past two-plus years.

Regardless, assuming nothing else changes, this should not affect your situation, nor our approach for this year. In your case, you are lucky to have an all-Democratic Congressional delegation (particularly in the House of Representatives). And, rest assured that we are well-placed even if Congress decided to ban all earmarks (which they did in FY 2007 when the Democrats took control of Congress).

I have a number of concerns with this whole dynamic, but in general I think the whole discussion is ridiculous from both sides of the aisle. The Democratic Administration wants to freeze discretionary spending, but that accounts for less than 1/3 of total outlays. Republicans think they can convince Americans that earmarks cause our deficits and total debt, when in fact they account for less than 1% of spending and the spending will not decrease if you remove earmarks. The spending decisions instead will simply revert to the Administration, which has happened with the Stimulus bill, which has not pleased Republicans at all.

BOARD OF DIRECTORS' MEETING-MARCH 25, 2010 ADDENDUM TO GENERAL MANAGER'S REPORT FINANCE MANAGER'S REPORT

<u>AUDIT</u>-The audited financial statements for the July 1, 2008 through June 30, 2009 fiscal year have been posted to the CCSD website.

<u>BUDGET</u>-The Mid-Year Budget and the Revenue and Expenditures for July 1, 2009 through December 31, 2009 have been posted to the CCSD website.

EXPENDITURES-There were no disbursements in excess of \$100,000 during February, 2010.

<u>RESERVES</u>-LAIF BALANCE-The balance in the Local Agency Investment Fund as of February 28, 2010 was \$4,525,890. This balance is an increase of \$50,000 from January 31, 2010 and an increase of \$224,765 from February 28, 2009. This represents the fourth consecutive month that the balance was higher than for the same month one year prior. In addition, the increases have been larger each subsequent month.

With the exception of the restricted funds to offset a potential future Proposition 1A take-away, restricted amounts are determined after all other fiscal year activity is recorded, reconciled and audited, although the balances are monitored during the fiscal year to ensure that funds set-aside for specific programs, such as the Lot Merger Program, are not overspent. Because the Proposition 1A funds are the result of a single transaction and not subject to the results of other activity, it is not necessary to wait for this process.

Prevention and Education (For the month of February 2010)

- **13** residential new and remodel fire plan reviews were completed.

Operations

• The Fire Department recently conducted the selection process for the Cambria Fire Department members who will attend paramedic school. An oral interview board consisting of Battalion Chief Rick Heath from Grover Beach FD, Captain/Paramedic Keith Aggson from Atascadero FD and Dr. Paul Georghiou from Sierra Vista Hospital and Cuesta College Paramedic program served to evaluate the candidates. The personnel selected to receive the training (funded by the AFG grant) were: Lt. Johnathan Gibson, Engineer Shawn Weber, Firefighter Sean Horton and Firefighter Matt Brody. Please join us in congratulating these personnel.

Prevention

- The CCSD Fire Department, Cal Fire and the Cambria Fire Safe Focus Group recently embarked on the process of compiling and completing a Community Wildfire Protection Plan (CWPP) for the community. This process will be facilitated by retired SLO City Fire Chief Bob Neuman and will identify specific strategies for wildfire management in and around Cambria. Implementation of the plan will also open up expanded opportunities for grant funding projects related to wildfire safety.

DISTRICT ENGINEER'S ADDENDUM TO GENERAL MANAGER'S REPORT

WELL LEVELS

Well level charts were not available at the time our agenda packet was being sent. Therefore, charts will be provided during the meeting as part of a verbal report. Currently, both aquifers are full, with flow occurring from each lagoon outlet into the ocean.

LEIMERT BOOSTER PUMPING STATION MODIFICATIONS

Variable frequency drives (VFDs) were completed at the Leimert Booster Pumping Station, which provides potable water to the Leimert neighborhood. The VFDs change the speed of the pumps to allow them to better match varying water demands, which lowers the frequency and number of start and stop cycles that had been occurring. The much smoother operation will prevent wear and tear on the pump starters, while also reducing pressure swings in the distribution system. This work was coordinated and supervised by Water Superintendent Jim Adams.

Stevan Rosenlind, 6535 Catherine. Concerned with project without full EIR and suggested Board take a field trip (non-technical) and walk beach.

Mary Webb, Cambria. Opposes categorical exemption and ND.

<u>Mahala Burton</u>, Cambria. Spoke in opposition and commented on lack of public notice and stated Gary Henderson, SLO City Engineer would give Cambria 602 AF of Whale Rock reservoir water. CCSD Minutes February 25, 2010 Page 3

<u>Mike Dill</u>, Paso Robles, Cambria. Vice President, United Lot Owners of Cambria (UNLOC). Spoke in support on behalf of 660 plus lot owners and their families and urged Board to move forward and pass Item 8A for the benefit of all Cambrians. <u>Elizabeth Bettenhausen</u>, Cambria. Spoke in opposition and commented on Initial Study is totally being inconsistent with the study done by the firm that the Army Corps Engineers hired.

<u>Jim Webb</u>, Cambria. Spoke in opposition and commented on steelhead living in Santa Rosa Creek and Army Corps' lack of specific methodology for assessing cumulative impacts.

<u>Jeff Hellman</u>, Cambria. Is there some reason the drilling can't be done in a ¼ mile some other direction where there is no wildlife activity? Expressed geologists have equipment that does underground surveys and it seems there must be more than one location. *President Sanders responded CCSD has done those surveys*. And that was the only location? *Director De Micco, responded for the record, "that President Sanders is exactly right.*" I think the main concern of the public that has its apprehensions is really the safeguarding and the respect for wildlife. I think it all revolves around that. More than we need more water. *A question and answer exchange among Hellman and the Board continued.*

President Sanders read into the record written comments received by the Board in support of adopting Resolution 10-2010: Barbara Moyer, Joseyln Thornburg, David and Lisa Callahan, Pat and Frank Budicin, Greg and Linda Hunter, Lonnie and Gloria Coffie, Rick and Nancy Rentler, Jim and Linda Ensley.

<u>Ron Crummitt</u>, Cambria. He and his wife are concerned about environment and the wildlife and support moving forward with the project; pleased to see that Colonel Magness, of the Army Corps of Engineers said he would keep environmental concerns in line when going forth with this process.

President Sanders closed the public hearing.

Director Clift stated for the public record, the emails the Board received were not solicited by him. He only recognized one name, Mr. Ensley, because he knew his name from other things. All parcels that are inspected and found to be either not cleared or non-compliant are placed on a contract list and are abated by the CCSD's contractor. The number of properties requiring clearance by the CCSD's contractor typically varies from 150 to 350 parcels.

NOW, THEREFORE, BE IT RESOLVED AND ORDERED by the Board of Directors of the CCSD as follows:

- <u>Section 1.</u> That the recitals set forth herein above are true, correct and valid.
- <u>Section 2.</u> That vegetation and hazardous Wildland fire fuels located on all vacant properties, which are located within said District, be and hereby are declared a public nuisance.
- <u>Section 3.</u> Notice to destroy, modify, abate and remove vegetation and other fire hazard fuels shall be given to the CCSD Fire Chief in conformance with cited California Health and Safety Code section(s); that notice shall include that parcel modification/clearance be performed by owners or locally certified contractors.
- <u>Section 4.</u> That said nuisance, unless otherwise corrected, shall be modified and abated by the CCSD, with the cost thereof to be assessed upon the parcels from which said nuisance is abated.
- <u>Section 5.</u> That a public hearing shall be held on the proposed modification/reduction of vegetation and Wildfire hazard fuels to provide an opportunity for all property owners having any objections to the proposed removal of such fire hazard fuels to be heard and given due consideration.
- <u>Section 6.</u> That the District Clerk be, and hereby is authorized and directed to publish notice of said hearing to property owners as their names and addresses

appear from the last equalized assessment roll as authorized by Health & Safety Code Section §14896.

<u>Section 7.</u> This resolution shall be signed by the President of the Board and attested by the Clerk of the Board of Directors of the CCSD.

BACKGROUND:

Government Code Section 61765.20 allows the CCSD to set maximum water and wastewater standby or availability charges. The charges will be fixed on or before August 1st of each calendar year. The first procedural step is setting public hearing dates to approve the charges for Fiscal Year 2010/2011.

Water and wastewater standby or availability charges are assessed by parcel. Such charges for water shall not exceed \$45 per acre of land or \$45 per each parcel of land less than one acre. Wastewater charges shall not exceed \$30 per acre of land or \$30 per parcel of land less than one acre.

The fees are charged to improved property owners and property owners whose projects have received "Intent to Serve" letters or connection permits. The funds are used to finance the CCSD's Capital Improvement Program.

RESOLUTION OF THE BOARD OF DIRECTORS OF THE CAMBRIA COMMUNITY SERVICES DISTRICT CONCERNING WATER AND WASTEWATER STANDBY OR AVAILABILITY CHARGES – SETTING PUBLIC HEARING DATE

WHEREAS, the Community Services District Act provides that the Cambria Community Services District (hereinafter referred to as "CCSD") may, on or before August 1st of any calendar year, fix water and wastewater standby or availability charges; and

WHEREAS, it is the public interest that the CCSD establish its water and wastewater standby or availability charges pursuant to Government Code Sections 61124(b) and 61765.12.

NOW, THEREFORE, BE IT RESOLVED AND ORDERED by the Board of Directors of the CCSD as follows:

- <u>Section 1</u>. That the recitals set forth herein above are true, correct and valid.
- <u>Section 2</u>. That the Board of Directors of the CCSD proposes to fix on or before August 1, 2010, water standby or availability charges for fiscal year 2010/2011 as follows:
 - a. For all parcels of one (1) acre or less, \$45.00.
 - b. For all unsubdivided land of more than one (1) acre, \$45.00 plus \$1.35 per acre over one (1) acre.
 - c. For all subdivided land of more than one (1) acre:
 - 1. For the first ten (10) acres, \$45.00 per acre.
 - 2. For all such land over the first ten (10) acres, \$1.35 per acre.

Such charges shall be made to all such lands within the CCSD, or outside its territorial limits, to which water service is made available by the CCSD for any purpose, whether or not the water is actually used. Unimproved properties that have not been issued an "Intent to Serve" letter or connection permit shall be exempt from this charge.

- <u>Section 3</u>. That the Board of Directors of the CCSD proposes to fix on or before August 1, 2010, wastewater standby or availability charges for fiscal year 2010/2011 as follows:
 - a. For all parcels of one (1) acre or less, \$30.00.
 - b. For all unsubdivided land of more than one (1) acre, \$30.00 plus \$.90 per acre over one (1) acre.
 - c. For all subdivided land of more than one (1) acre:
 - 1. For the first ten (10) acres, \$30.00 per acre.
 - 2. For all such land over the first ten (10) acres, \$.90 per acre.

Such charges shall be made to all such lands within the CCSD, or outside its territorial limits, to which wastewater collection and treatment service is made available by the CCSD for any

purpose, whether the wastewater service is actually used or not. Unimproved properties that have not been issued an "Intent to Serve" letter or connection permit shall be exempt from this charge.

- <u>Section 4</u>. That the Board of Directors of the CCSD intends to hold public hearings concerning said water and wastewater standby or availability charges to be held on April 22, 2010, and May 27, 2010, at 12:30 PM at the following address: Cambria Veteran's Memorial Building, 1000 Main Street, Cambria, California.
- <u>Section 5</u>. That the District Clerk for the CCSD is authorized and directed to publish a notice of said public hearings prior to the date set for the hearings in a newspaper, of general circulation, printed and published in San Luis Obispo County, and after the setting of the fees, the CCSD's Finance Manager will mail each assessed property owner a notice of the filing of the water and wastewater standby or availability report.
- <u>Section 6</u>. At said public hearings, any person interested, including all persons owning property in the CCSD, may appear and be heard on the matter of the water and wastewater standby or availability charges of the CCSD.
- <u>Section 7</u>. At the time a place fixed in the notice for the hearings, the Board of Directors shall hold the hearings and may adjourn said hearings from time to time and may adjourn said hearing to a different place, if deemed necessary.

General Fund/CCSD Fire Department

FY 2010/2011:\$28,000 increase in Personnel costs, which is offset by \$8,600 (2% PERS/Employee Share retirement contribution)*

Estimated net increase for FY 2010/2011 = \$19,400*

*Does not include potential cost-of-living increase, effective 3/26/11. Depends on the U.S. Social Security National index.

Health Benefit and HRA benefit savings were included within Prop 1A savings calculations.

DISCUSSION:

The CCSD and IAFF have been involved in labor negotiations since the IAFF contract expired last year on June 30, 2009. Overall, the negotiations between the CCSD and the IAFF have been professional. Impasse was declared by the IAFF on November 6, 2009, and the single issue in dispute was over wages. Per CCSD Code Section 2.04.200, which provides final resolution for the impasse procedure, President Sanders and Vice President Clift met with the IAFF over the wage issues and negotiated a settlement, which is described below.

The following summarizes the highlighted changes within the attached MOU:

1. <u>TERM</u> – The term for the newly negotiated IAFF MOU will be two years from March 26, 2010, through March 25, 2012.

2. <u>SALARY AND PERS RETIREMENT/EMPLOYEE PORTION</u> – Salary increases and/or PERS retirement contributions as follows:

- A. 2% retroactive to 7/1/09 through March 25, 2010.
- B. 4.1% effective March 26, 2012, <u>together with</u> employee paying 2% of the Employee share of PERS retirement.
- C. Cost-of-living increase, based upon the national annual index for cost-of-living increases for Social Security recipients, not to exceed 2.5%, effective March 26, 2011. Employee pay will not be reduced if the national annual index is a negative percentage (or less than 0%).
- D. Effective March 26, 2010, all new hire IAFF employees will pay 100% of the 9% Employee share of PERS retirement. This will be incorporated into the CCSD Code via ordinance, thereby eliminating it from future labor negotiations. (*Note: An Ordinance will be introduced to the Board at its next regular meeting.*)

3. <u>MOU LANGUAGE CLARIFICATIONS</u> – Ministerial IAFF MOU language clarifications/additions/deletions, as submitted in its "strikethrough" version of the MOU (transmitted via email on 7/23/09).

4. <u>ACTING CHIEF PAY</u> – Acting Chief Pay policy. Proposed added provision for Acting Chief pay to Section 33, "Working out of Class," providing for 5% Acting Chief Pay, after four (4) consecutive work days have passed.

5. <u>HEALTH BENEFITS</u> – Clarify that the CCSD "will pay 95% of the premiums for employee and dependent coverage for the lowest cost plan offered through the PERS system." The proposal is to drop the parenthetical reference to "PERS Choice." The lowest cost PERS plan is now the Blue Shield Net Value HMO.

Proposed MOU provision:

24. <u>HEALTH BENEFITS</u>

A. Effective January 1, 2005, for all regular employees working half-time or more, the CCSD will pay 95% of the premiums for employee and dependent coverage for the lowest cost plan offered through the PERS system. In the event an employee elects a higher cost coverage, the employee shall pay the increased cost for that plan. CCSD premium payments apply to retirees and their dependents as applied to active employees and their dependents.

Note: Section 24.(B) remains unchanged.

6. <u>HEALTH REIMBURSEMENT ACCOUNT (HRA)</u> – Side Letter No. 1 reflecting employee "give back" of one-half of employee HRA benefit, retroactive to January 1, 2010, through June 30, 2010.

RESOLUTION 08-2010

The attached Resolution 08-2010 is required by PERS confirming the payment by the CCSD of the proportionate share 78% (7/9ths) of the designated Employee contribution of PERS retirement costs.

RESOLUTION 09-2010

Finally, the attached Resolution 09-2010 is required by PERS per IRC (Internal Revenue Code) 414 (H)(2) to confirm tax deferred status of the CCSD's payment of the designated Employee contribution of PERS retirement costs.

- 1. This benefit shall consist of the CCSD paying 78% (7/9ths) of the normal member contributions as EPMC for the Cambria Firefighters/IAFF Local 4635 in the CCSD's employ on March 25, 2010;
- 2. This benefit shall consist of paying 0% of the normal member contributions as EPMC for all new hire Cambria Firefighters/IAFF Local 4635, effective March 26, 2010;
- 3. This benefit shall consist of paying 0% of the normal member contributions as EPMC for eligible CCSD Reserve Firefighters; and
- 4. This benefit shall consist of paying 100% of the normal contribution as EPMC for all other regular CCSD employees.

BE IT FURTHER RESOLVED that this Resolution supersedes anything inconsistent, including but not limited to, Resolution 42-2008.

RESOLUTION 15-2010

A RESOLUTION OF THE BOARD OF DIRECTORS OF THE CAMBRIA COMMUNITY SERVICES DISTRICT FOR EMPLOYER PICK-UP – IRC 414 (H)(2)

The Board of Directors of the Cambria Community Services District does hereby resolve as follows:

WHEREAS, the CAMBRIA COMMUNITY SERVICES DISTRICT has the authority to implement the provisions of section 414(h)(2) of the Internal Revenue Code (IRC); and

WHEREAS, the Board of Administration of the Public Employees' Retirement System adopted its resolution regarding section 414(h)(2) IRC on September 18, 1985; and

WHEREAS, the Internal Revenue Service has stated in December 1985, that the implementation of the provisions of section 414(h)(2) IRC pursuant to the Resolution of the Board of Administration would satisfy the legal requirements of section 414(h)(2) IRC; and

WHEREAS, the CAMBRIA COMMUNITY SERVICES DISTRICT has determined that even though the implementation of the provisions of section 414(h)(2) IRC is not required by law, the tax benefit offered by section 414(h)(2) IRC should be provided to its employees who are members of the Public Employees' Retirement System:

NOW, THEREFORE, BE IT RESOLVED:

- I. That the CAMBRIA COMMUNITY SERVICES DISTRICT will implement the provisions of section 414(h)(2) Internal Revenue Code by making employee contributions pursuant to California Government Code section 20691 to the Public Employees' Retirement System on behalf of its employees who are members of the Public Employees Retirement System. "Employee contributions" shall mean those contributions to the Public Employees' Retirement System which are deducted from the salary of employees and are credited to individual employee's accounts pursuant to California Government Code section 20691.
- II. That the contributions made by the CAMBRIA COMMUNITY SERVICES DISTRICT to the Public Employees' Retirement System, although designated as employee contributions, are being paid by the CAMBRIA

COMMUNITY SERVICES DISTRICT in lieu of contributions by the employees who are members of the Public Employees' Retirement System.

- III. That employees shall not have the option of choosing to receive the contributed amounts directly instead of having them paid by the CAMBRIA COMMUNITY SERVICES DISTRICT to the Public Employees' Retirement System.
- IV. That the CAMBRIA COMMUNITY SERVICES DISTRICT shall pay to the Public Employees' Retirement System the contributions designated as employee contributions from the same source of funds as used in paying salary.
- V. That the amount of the contributions designated as employee contributions and paid by the CAMBRIA COMMUNITY SERVICES DISTRICT to the Public Employees' Retirement System on behalf of an employee shall be the entire contribution required of the employee by the Public Employees' Retirement Law (California Government Code sections 20000, et seq.).
- VI. That the contributions designated as employee contributions made by CAMBRIA COMMUNITY SERVICES DISTRICT to the Public Employees' Retirement System shall be treated for all purposes, other than taxation, in the same way that member contributions are treated by the Public Employees' Retirement System.
